
CARISMA and DEEDS ensure continuity of the portal

The <u>ClimateChangeMitigation.eu</u> portal has been initiated by the EU-funded CARISMA project. In order for the portal to be maintained also after CARISMA finalises (July 2018), the project collaborates with the new DEEDS project to transfer ownership. <u>DEEDS</u> runs until September 2020, which means that the portal can be maintained and strengthened over the coming years.



LINKS at COP23 During three events of the *CD*-*LINKS* project at COP23 in Bonn, comparisons of the NDCs and strategies to reach the 1.5 and 2°C goals for key countries like Brazil, China, the European Union, and India, were made.



Meta-analysis of climate change policy evaluations in the EU Evaluation of climate change mitigation policy is crucial for understanding how well policies and measures work. CARISMA carried out a metaanalysis of such evaluations in the EU and Member States.



Expert assessment of risks in climate change mitigation pathways

The **TRANSrisk** project is exploring how risks associated with policies may enhance or constrain different carbon mitigation pathways.

About the portal for EU-funded mitigation research

EU-funded projects on climate change mitigation are invited to upload highlights of their work on the <u>ClimateChangeMitigation.eu</u> portal. The portal is managed under the Horizon 2020 project CARISMA and has been developed by a group of EU-funded research and coordination projects for **a wider outreach** of their results

The portal contains short articles on a **range of topics**, such as technologies for mitigation, scenarios for low-emission transitions, policies, case studies and stakeholder engagement.



The portal has been launched by the EU-funded CARISMA project. Thirteen other (finalised and ongoing) EU-funded mitigation research and coordination projects have joined (see <u>Related EU</u> <u>projects</u>). Additional projects are invited to become involved as well.
